Welcome to the second edition of the MAJALAT Brussels Civil Society Forum!

### What is MAJALAT?

In Arabic, the word Majalat means "spaces, opportunities, fields and domains". This initiative aims to create spaces for constructive dialogue between the European Union (EU) and civil society organisations (CSOs), trade unions, social movements and academics from both sides of the Mediterranean, with the aim of influencing the vision and policies related to the region.

Majalat is a regional initiative supported by the European Commission (DG NEAR). The consortium that manages the project is composed of six regional networks of civil society: EuroMed Rights, the Arab NGO Network for Development (ANND), the Arab Trade Union Confederation (ATUC), the REF - Euromed France Network, le Forum des alternatives Maroc (FMAS) and SOLIDAR.

## **Another Civil Society Forum?**

This unique initiative aims to create a permanent exchange between the EU and the civil society organisations of the Southern Mediterranean countries, taking into account the previous dialogues led by the EU. The Brussels Civil Society Forum is the culmination of a full cycle of activities with thematic workshops, national workshops, a workshop for young people; and the South seminar.

## What is on the menu?

This year, five specific themes will be discussed with EU high level representatives and officials. Gender, youth and non-discrimination issues will also be integrated in the discussions as cross-cutting themes.

- · Good governance and the rule of law
- Security and countering violence
- Migration
- Economic development and social dialogue
- Climate and social justice

The purpose of this second Brussels Civil Society Forum is to deepen the recommendations identified during the 2019 event cycle and to discuss implementation tracks and collaboration between CSOs and the EU.
